Book Review by Sinda Dux:

Charles W. Ore: an American Original

A **Festschrift** (German) is a book honoring a respected person and presented during his or her lifetime. The Lincoln AGO Chapter was honored to be asked by the Center for Church Music to contribute money toward the publication of this book honoring our own long-time chapter member and former Dean, Charles Ore.

From the foreword by noted organist, John Behnke: "Some creative people are totally absorbed in themselves and their work and then there's Charles Ore, who is creative beyond belief, yet magnanimous with encouragement for others and care and concern for all. His life and his music should be known to all church musicians."

The book is edited by Irene Beethe, a graduate of Concordia University, Seward, who babysat for the Ore family and who wrote her master's thesis on Charles' music. The book begins with a biography starting around 1700, when the paternal ancestors of Charles came to the Colonies and fought against the British in the Revolutionary War. Charles' grandfather eventually moved to Kansas. Charles' father had been raised Baptist; thus Charles was familiar with Baptist hymnody. Charles was raised a Lutheran and his mother taught him Lutheran hymns. His musical talent manifested itself early on and his family encouraged his musical education. His first piano teacher fostered his improvisational talents.

At 17 years of age, Charles was introduced to the organ by his home church organist on a two-manual, tracker-action Kilgen with a straight pedal board and Charles was "hooked" on organ from then on. The Festschrift details Charles' educational and work history.

Further chapters of the book give detailed analyses and reproductions of pages of Charles' compositions, both organ and choral. The chapter on choral compositions is written by long-time Lincoln AGO Chapter member and former Dean, David Held.

Readers will find in this book many things -- a detailed biography of Charles' life, a listing of his compositions, a "how-to" for playing his works and for improvising, and chapters on hymnody.

One beautiful and moving chapter is a sampling of Connie Ore's blogs after she was diagnosed with an incurable condition. The chosen writings are called "Hymns and the Care of the Soul."

AGO Agrees to FTC Order

The Federal Trade Commission (FTC) has conducted an investigation concerning certain provisions in the American Guild of Organists (AGO) Code of Ethics and other documents. The investigation focused on:

- A Code of Ethics provision that prohibits members from applying for a position held by someone else unless there has been a public announcement of a vacancy for that position;
- A Code of Ethics provision that requires a member engaged for a wedding, funeral, or other service to (1) obtain the approval of the incumbent musician before accepting, and (2) tell the party requesting the service to pay the incumbent his/her customary fee; and
- The AGO's publication of (1) lists and schedules of compensation and fees for its members to use, (2) standard methods and formulas for Chapters to provide to members for calculating compensation and fees, and (3) other model contract provisions.

To end the investigation expeditiously and to avoid disruption to its core functions, the AGO has voluntarily agreed to a Consent Agreement and entry of a final Decision and Order by the FTC. In doing so, however, the AGO has not admitted any law violation.

In general, the FTC's Order prohibits the AGO from:

- maintaining bylaws, a code of ethics, operational policies, or membership requirements that restrict its members from competing with one another for positions or for engagements for weddings, funerals, or other services, or competing in any other way, including on price;
- interfering with members' efforts to provide services and to compete on price;
- publishing documents such as fee schedules and model contracts for members to use when determining or securing compensation for their services.

The Order also requires the AGO to establish an antitrust compliance program.

All AGO members should be aware of these developments and abide by the terms of the AGO's settlement with the FTC.
